INVESTING IN VANCOUVER YOUTH

The Foundation for Vancouver Public Schools (VPS) serves 22,000 youth in 37 schools and programs. Support for the Foundation for VPS helps students in need overcome barriers to learning and enriches the school experience to promote achievement for all students.

The students we serve:

Nearly 50% of VPS students are from families with incomes below federal poverty guidelines (i.e., qualifying for free or reduced-price lunch), with some schools as high as 86%.

800+ students experienced homelessness during the past school year.

Approximately 1 out of 5 VPS students are chronically absent.

Our students are from diverse backgrounds, with 70 languages spoken.

By leveraging funds along with community resources, we can quickly meet emerging needs.

In 2020-21, funding to the Foundation for VPS addressed barriers to learning associated with poverty, supporting students through:







COMMUNITY IMPACT HIGHLIGHTS


Thanks to donors...

Barriers to learning associated with poverty were removed so that students could come to school happy, healthy, and ready to learn.

Students accessed engagement opportunities and connected with mentors to spark their interests, discover their passions, and envision their future.

School communities were strengthened by family and community engagement activities.

Early learning initiatives helped our youngest learners begin school ready to learn.



2020-21 impact at a glance...

- Basic needs funding, including Emergency Checkbooks, thrift store vouchers, and grocery store gift cards for emergency needs at all 37 school buildings
- Housing stability assistance prevented eviction of 149 children from 71 families
- Vision, dental, mental, and other health services were provided to students
- School supplies and basic needs support to helped students in need start the school year ready to learn
- Over \$60,000 in enrichment grants and engagement activities benefited students through projects, programs, and experiences inside and out of the classroom
- Mentoring programs, after school sports programs, and camps were provided free of charge
- VPS Family-Community Resource coordinators hosted 99 online and in-person family engagement events
- 1-2-3 Grow & Learn hosted 191 sessions, engaging 2,959 children (birth-5) and their caregivers



Looking ahead to 2021-22...

VPS FCRCs and staff will continue to mobilize in-kind donations and community resources to stabilize students and families at each VPS school. Thanks to financial donations from thousands of supporters, the Foundation for VPS provides VPS with flexible funding to bridge the gap for students with the greatest unmet basic needs. We also provide all students with opportunities for enrichment, mentoring, early learning, and family and community engagement to cultivate and inspire student success.

Some examples of planned Foundation support include:

- \$300,000 direct basic needs support
- \$100,000 school engagement grants
- \$100,000 student enrichment, mentoring programming support for on-site and off-site out of school time programming and experience labs
- \$65,000 family and community engagement opportunities that strengthen family capacity to support student success
- Resources to decrease absenteeism and support social-emotional health and resilience
- Early learning programming



SCHOOL-COMMUNITY PARTNERSHIPS



It starts with a simple premise. In order to address the biggest challenges facing Vancouver children, and to achieve systemic and lasting improvements, the path for change leads through local schools and community support.

Vancouver Public School's Community Schools model unites schools, families, and communities to address opportunity and achievement gaps and improve student learning.

The district's Family-Community Resource Centers (FCRCs) serve all VPS schools through a network of 23 on-site centers and two mobile units, providing families with access to academic and early learning programs, health and social services, youth and community activities, and other services and resources.

Leveraging resources



For every \$1 of funding, \$4.25 of resources and services are leveraged through community partners.

Performance Outcomes

VPS measures success by student achievement, safe and supportive environments, and parent and community involvement. VPS data and teacher reports document the impact on student learning:

- Improved student performance
- Increased graduation rates
- Decreased absences
- Reduced disciplinary actions
- Smaller performance gaps between students of diverse ethnic & economic backgrounds

Planned Giving

- Make a gift through your estate by naming the Foundation for VPS in your will or living trust.

FUND A NEED:

- \$25 buys a grocery or gas gift card

- \$250 allows an at-risk child to develop basic literacy skills entering Kindergarten
